\$100,000 PACIFIC BOATING MEMBERSHIP PROMOTION
TERMS and CONDITIONS

INTRODUCTION

- 1 Information on how to enter and about Prizes form part of these Terms and Conditions. Participation in the Sydney Boat Show ("Show") Scan to Win Promotion ("Promotion") is deemed acceptance of these Terms and Conditions.
- 2 The Show is held from 30 July – 2 August 2026 at the Sydney Showground at Olympic Park.
- 3 The Promoter is the Boating Industry Association ABN 61 000 618 468 2 Maritime Court Rozelle NSW 2039 ("Promoter's Office").
- 4 The Prize Supplier is Pacific Boating Group Pty Ltd ABN 38 117 497 364 of 5/2 Waterways Court, Rozelle 2039 ("Prize Supplier")

ELIGIBILITY

- 5 Entry is open to Australian Citizens and Permanent Residents residing in Australia aged 30 years or older on 30 July 2026 who have purchased a ticket to enter the Show ("Eligible Entrants") and comply with the "How to Enter" requirements. Employees of the Promoter and the Prize Supplier or their associated entities, contractors and agencies and their immediate family members are not permitted to enter.

PROMOTION PERIOD

- 6 The Promotion commences at 9 am on 26 June 2026 and ends at 4pm on 2 August 2026. ("Promotion Period").

HOW TO ENTER

- 7 To enter you can:
 - a. visit the Promoter's website, purchase a ticket and click on the Prize Supplier's online banner and when prompted insert your ticket number and your contact details (name, phone and email); and / or
 - b. visit the Prize Supplier's stand and using your mobile telephone scan the Prize Supplier's QR code and when prompted insert your ticket number and your contact details (name, phone and email); and / or
 - c. visit The Prize Supplier's QR code located at the main Show entrance and using your mobile telephone scan the Prize Supplier's QR code and when prompted insert your ticket number and your contact details (name, phone and email).

PRIZES and PRIZE DRAW AND DRAW DETAILS

- 8 You are permitted to enter the draw a maximum of 3 times as follows:
 - a. by clicking on the Prize Supplier's banner on the Promoter's website;
 - b. by visiting the Prize Supplier's exhibition stand and scanning the QR code at the stand and when prompted inserting your ticket number and your contact details (name, phone and email);
 - c. by scanning the Prize Supplier's QR code at the Show entrance and when prompted inserting your ticket number and your contact details (name, phone and email).
- 9 The Prize consists of 4 x Pacific Boating vouchers each valued at \$25,000 including GST to be redeemed on Pacific Boating Memberships. The Prize Supplier is responsible for and liable to deliver the Prizes. The total Prize pool is valued at \$100,000 including GST.
- 10 The prize winners may only redeem the Prize on Pacific Boating Memberships to the value of \$25,000 including GST. The prize winners will be drawn at the conclusion of each day of the Event. The Prize Supplier will conduct 4 draws in total. Entrants (excluding the daily prize winner from the previous day/s) will remain in the Prize draw for the entire Promotion.

- 13 Each Prize draw will be conducted electronically and will take place at approximately 4pm on each day of the Show. The first Eligible Entrant's entry drawn will win the daily Prize.

WINNER NOTIFICATION

- 8 The Prize winners will be announced daily at the Show and notified in writing by email and phone within 7 days of the draw. Prizes must be claimed within **one month**. The winner's names (once verified) will be published on the Prize Supplier's website and the Show's website on the date of each the draw.

UNCLAIMED PRIZES

- 9 A draw for any unclaimed Prize will take place at 10 am on 13 October 2026 at the Prize Supplier's Office - subject to any directions of a regulatory authority. The winner/s (if any) will be notified by email and phone and their name published on the Prize Supplier's and the Show's website on the date of the redraw.

PRIZE COLLECTION/REDEMPTION

- 10 Subject to paragraph 14, the Prize Supplier will contact each winner to make arrangements for each Prize winner to redeem their Prize. The Prize must be redeemed by 30 June 2027.

PRIVACY

- 11 The Promoter and Prize Supplier will collect personal information ("PI") from each entrant in order to conduct this Promotion and may disclose this PI to regulatory authorities and relevant third parties, including its related entities, agents and the Promoter. The Promoter and the Prize Supplier and these third parties may use this PI for promotional, marketing, research and profiling purposes (including sending electronic messages or phoning the entrants) in accordance with the law and their respective privacy policies. General Matters and Exclusion of Liability

- 13 The Promoter and the Prize Supplier reserve the right to verify the validity of entries and entrants and disqualify any entrant who submits an entry that is not in accordance with these Terms & Conditions or who tampers with the entry process.
- 14 If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Prize Supplier or Promoter, the Prize Supplier or Promoter may, to the fullest extent permitted by law and subject to any written directions from a relevant authority, modify, suspend, terminate or cancel the Promotion, as appropriate.
- 15 These Terms and Conditions contain the Prize offer from the Prize Supplier who is not a related corporation of the Promoter. Subject to any applicable law which cannot be excluded, the Promoter and Prize Supplier make no warranties or representations regarding the suitability, availability, quality, accuracy, merchantability or fitness for purpose of the goods or services offered as the Prize. Your entering this competition and obtaining of the Prize from the Prize Supplier is at your own risk. All Prize information and other information concerning the Prize is provided by the Prize Supplier and the Promoter advises you to confirm pricing and other details, membership details with the Prize Supplier for the most accurate information about personal and other expenses, availability and risks associated with redeeming the Prize.
- 16 You indemnify the Promoter and Prize Supplier against all liability, loss, damage, cost and expense arising from or relating to your winning and redeeming the prize in this Promotion. The Promoter and Prize Supplier excludes all liability (including negligence), for any personal injury or any loss or damage - whether direct, indirect, special or consequential, arising in any way out of this Promotion or the awarding, redemption or use of the Prize.
- 17 The Promoter or a Prize Supplier reserves the right to request winners to sign a winner's deed of release or any other relevant forms or agreements that the Promoter or Prize Supplier deems necessary, to provide proof of identity, proof of age, proof of residency and/or proof of entry validity in order to claim a Prize. - 20 If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter may, to the fullest extent permitted by law and subject to any written directions from a relevant authority, modify, suspend, terminate or cancel the Promotion, as appropriate.
- 21 The Promoter's or Prize Supplier's decision is final, and no correspondence will be entered into with respect to it.
